
Pittsfield (Merrimack)

Pittsfield is a town in Merrimack County with 927 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of anemia, fibromyalgia/chronic pain/fatigue, liver disease, migraine, osteoporosis, peripheral vascular disease, PTSD, and schizophrenia. Older residents in Merrimack County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (73.2%) and annual dental exams (69.4%), while 52.5% of men and 46% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include one senior center and one public library.
