Richmond (Cheshire)

Richmond is a town in Cheshire County with 319 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of high cholesterol, benign prostatic hyperplasia, migraine, and schizophrenia. However, they have higher rates of Alzheimer's disease or related dementias, chronic obstructive pulmonary disease (COPD), fibromyalgia/chronic pain/fatigue, and tobacco use disorder. Older residents in Cheshire County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (66.3%) and annual dental exams (65.5%), while 50.1% of men and 41.5% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. A community resource to support healthy aging is their public library.
