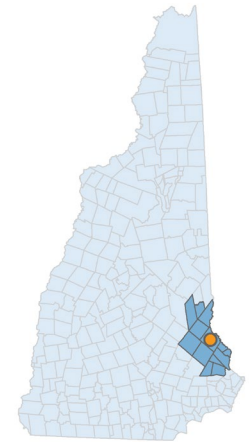


Rochester (Strafford)

Rochester is a city in Strafford County with 6,031 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of cataract, glaucoma, and osteoporosis. However, they have higher rates of high cholesterol, benign prostatic hyperplasia, chronic kidney disease, chronic COPD, colon cancer, CHF, diabetes, fibromyalgia, hypertension, ischemic heart disease, liver disease, peripheral vascular disease, pressure ulcer, tobacco use disorder, depression, and anxiety disorder. Older residents in Strafford County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (72.8%) and annual dental exams (67.4%), while 48.3% of men and 38.4% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources include nine primary care providers, one hospital, one home health agency, two skilled nursing facilities, one hospice agency, one community health center, one senior center, one public university or community college, and two public libraries.

TECHNICAL NOTES

*For more information on data sources, measures, and methodology used in the 2025 New Hampshire Healthy Aging Data Report see our technical documentation at (healthyagingdatareports.org). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms “Better” and “Worse” to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
