
## Salem (Rockingham)

Salem is a town in Rockingham County with 5,794 residents aged 65 or older. Compared to state average rates, older residents have a lower rate of PTSD. However, they have higher rates of high cholesterol, anemia, asthma, atrial fibrillation, benign prostatic hyperplasia, breast cancer, cataract, chronic kidney disease, COPD, colon cancer, CHF, diabetes, glaucoma, hypertension, ischemic heart disease, lung cancer, arthritis, osteoporosis, peripheral vascular disease, stroke, tobacco use disorder, and anxiety disorder. Older residents in Rockingham County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (75.2%) and annual dental exams (74.3%), while 48.6% of men and 41.7% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources include 30 primary care providers, two home health agencies, one skilled nursing facility, one assisted living facility, one adult day health center, one senior center, and one public library.
