
Sandown (Rockingham)

Sandown is a town in Rockingham County with 740 residents aged 65 or older. Compared to state average rates, older residents have a lower rate of cataract. However, they have a higher rate of chronic kidney disease. Older residents in Rockingham County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (75.2%) and annual dental exams (74.3%), while 48.6% of men and 41.7% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. A community resource to support healthy aging is their public library.
