Stoddard (Cheshire)

Stoddard is a town in Cheshire County with 235 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of high cholesterol, anemia, chronic kidney disease, chronic obstructive pulmonary disease (COPD), diabetes, heart attack, hypertension, ischemic heart disease, liver disease, lung cancer, peripheral vascular disease, substance and tobacco use disorders, anxiety disorder, PTSD, and schizophrenia. Older residents in Cheshire County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (66.3%) and annual dental exams (65.5%), while 50.1% of men and 41.5% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. A community resource to support healthy aging is their public library.
