
Sullivan (Cheshire)

Sullivan is a town in Cheshire County with 129 residents aged 65 or older. Compared to state average rates, older residents have a lower rate of high cholesterol. However, they have higher rates of Alzheimer's disease or related dementias, anemia, cataract, congestive heart failure (CHF), fibromyalgia/chronic pain/fatigue, osteoarthritis/rheumatoid arthritis, osteoporosis, peripheral vascular disease, pressure ulcer, stroke, and depression. Older residents in Cheshire County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (66.3%) and annual dental exams (65.5%), while 50.1% of men and 41.5% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. A community resource to support healthy aging is their public library.
