## Sunapee (Sullivan)

Sunapee is a town in Sullivan County with 887 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of high cholesterol, Alzheimer's disease or related dementias, asthma, cataract, chronic kidney disease, congestive heart failure (CHF), diabetes, fibromyalgia/chronic pain/fatigue, glaucoma, hypertension, ischemic heart disease, peripheral vascular disease, tobacco use disorder, depression, anxiety disorder, and schizophrenia. Older residents in Sullivan County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (71.9%) and annual dental exams (64.1%), while 51.4% of men and 42.5% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. A community resource to support healthy aging is their public library.
