
Surry (Cheshire)

Surry is a town in Cheshire County with 243 residents aged 65 or older. Compared to state average rates, older residents fare worse on some healthy aging indicators with higher rates of high cholesterol, Alzheimer's disease or related dementias, anemia, cataract, congestive heart failure (CHF), fibromyalgia/chronic pain/fatigue, osteoarthritis/rheumatoid arthritis, osteoporosis, peripheral vascular disease, pressure ulcer, stroke, and depression. Older residents in Cheshire County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (66.3%) and annual dental exams (65.5%), while 50.1% of men and 41.5% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. A community resource to support healthy aging is their public library.
