Tamworth (Carroll)

Tamworth is a town in Carroll County with 574 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of Alzheimer's disease or related dementias, benign prostatic hyperplasia, chronic kidney disease, ischemic heart disease, migraine, pressure ulcer, prostate cancer, and schizophrenia. Older residents in Carroll County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (74.6%) and annual dental exams (66.3%), while 53.8% of men and 40.9% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include one primary care provider and one public library. Tamworth is a designated AARP Age-Friendly Community.
