Tuftonboro (Carroll)

Tuftonboro is a town in Carroll County with 946 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of Alzheimer's disease or related dementias, chronic kidney disease, congestive heart failure (CHF), diabetes, glaucoma, migraine, peripheral vascular disease, substance use disorder, depression, anxiety disorder, and schizophrenia. However, they have a higher rate of benign prostatic hyperplasia. Older residents in Carroll County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (74.6%) and annual dental exams (66.3%), while 53.8% of men and 40.9% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. A community resource to support healthy aging is their public library.
