
Wilton (Hillsborough)

Wilton is a town in Hillsborough County with 789 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of hip fracture, high cholesterol, chronic obstructive pulmonary disease (COPD), diabetes, pressure ulcer, tobacco use disorder, PTSD, and schizophrenia. Older residents in Hillsborough County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (72.8%) and annual dental exams (69.8%), while 47.8% of men and 38.3% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. A community resource to support healthy aging is their public library.
