
Windham (Rockingham)

Windham is a town in Rockingham County with 2,542 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of hip fracture, PTSD, and schizophrenia. However, they have higher rates of high cholesterol, benign prostatic hyperplasia, cataract, chronic kidney disease, hypertension, and peripheral vascular disease. Older residents in Rockingham County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (75.2%) and annual dental exams (74.3%), while 48.6% of men and 41.7% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include 42 primary care providers, one skilled nursing facility, one assisted living facility, one senior center, and a public library.
