Manchester: South (Hillsborough)

Manchester South is a neighborhood of Manchester in Hillsborough County with 4,529 residents aged 65 or older. Compared to state average rates, older residents fare worse on some healthy aging indicators with higher rates of high cholesterol, Alzheimer's disease or related dementias, anemia, asthma, chronic kidney disease, chronic obstructive pulmonary disease (COPD), congestive heart failure (CHF), diabetes, fibromyalgia/chronic pain/fatique, glaucoma, hypertension, ischemic heart disease, osteoporosis, stroke, and tobacco use disorder. Older residents in Hillsborough County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (72.8%) and annual dental exams (69.8%), while 47.8% of men and 38.3% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include 75 primary care providers, a hospital, five community health centers, and an Alzheimer's caregiver support group.
