Nashua Northwest is a neighborhood of Nashua in Hillsborough County with 4,664 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of hip fracture, chronic obstructive pulmonary disease (COPD), peripheral vascular disease, and tobacco use disorder. However, they have higher rates of high cholesterol, anemia, chronic kidney disease, hypertension, osteoporosis, and anxiety disorder. Older residents in Hillsborough County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (72.8%) and annual dental exams (69.8%), while 47.8% of men and 38.3% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include 32 primary care providers, two home health agencies, two community health centers, one public university or community college, and an Alzheimer's caregiver support group.
