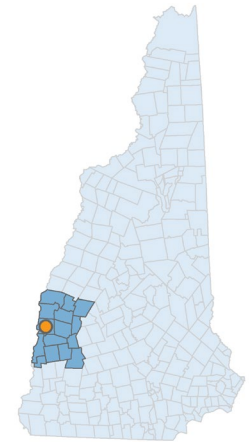


## Claremont (Sullivan)

Claremont is a city in Sullivan County with 2,646 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of high cholesterol, benign prostatic hyperplasia, breast cancer, cataract, glaucoma, osteoarthritis/rheumatoid arthritis, osteoporosis, prostate cancer, and anxiety disorder. However, they have higher rates of Alzheimer's disease or related dementias, chronic obstructive pulmonary disease (COPD), diabetes, heart attack, peripheral vascular disease, tobacco use disorder, and depression. Older residents in Sullivan County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (71.9%) and annual dental exams (64.1%), while 51.4% of men and 42.5% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include 17 primary care providers, one hospital, one skilled nursing facility, one senior center, one public university or community college, and one public library.

## TECHNICAL NOTES

\*For more information on data sources, measures, and methodology used in the 2025 New Hampshire Healthy Aging Data Report see our technical documentation at ([healthyagingdatareports.org](http://healthyagingdatareports.org)). For most indicators, the community and state values are estimates derived from sample data. Thus, it is possible that some of the differences between state and community estimates may be due to chance associated with population sampling. We use the terms “Better” and “Worse” to highlight differences between community and state estimates that we are confident are not due to chance. We balance two goals. First, we aim to report data at very local levels because we believe change is often locally driven. Second, we vowed to protect the privacy of the people providing the information reported. Thus, given the constraints of the data analyzed, we used a hierarchical approach to reporting.
