Columbia (Coös)

Columbia is a town in Coös County with 162 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of asthma, cataract, fibromyalgia/chronic pain/fatigue, glaucoma, liver disease, osteoarthritis/rheumatoid arthritis, and schizophrenia. However, they have higher rates of diabetes and PTSD. Older residents in Coös County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (74.3%) and annual dental exams (56.9%), while 46.2% of men and 35% of women 65 and older completed all CDC recommended vaccinations and cancer screenings.
