
## **Enfield (Grafton)**

Enfield is a town in Grafton County with 1,254 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of high cholesterol, Alzheimer's disease or related dementias, anemia, benign prostatic hyperplasia, cataract, chronic kidney disease, chronic obstructive pulmonary disease (COPD), congestive heart failure (CHF), hypertension, ischemic heart disease, peripheral vascular disease, pressure ulcer, substance use disorder, and anxiety disorder. However, they have a higher rate of depression. Older residents in Grafton County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (70.4%) and annual dental exams (67.2%), while 48.6% of men and 42.7% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. A community resource to support healthy aging is their public library.
