
## **Exeter (Rockingham)**

Exeter is a town in Rockingham County with 3,749 residents aged 65 or older. Compared to state average rates, older residents have a lower rate of tobacco use disorder. However, they have higher rates of high cholesterol, Alzheimer's disease or related dementias, anemia, benign prostatic hyperplasia, breast cancer, cataract, glaucoma, liver disease, migraine, osteoarthritis/rheumatoid arthritis, osteoporosis, peripheral vascular disease, prostate cancer, depression, and anxiety disorder. Older residents in Rockingham County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (75.2%) and annual dental exams (74.3%), while 48.6% of men and 41.7% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include 49 primary care providers, one hospital, one home health agency, two skilled nursing facilities, two hospice agencies, one community health center, one senior center, and one public library. Exeter is a designated AARP Age-Friendly Community.
