
Fremont (Rockingham)

Fremont is a town in Rockingham County with 766 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of asthma, cataract, and stroke. However, they have higher rates of hypertension, liver disease, anxiety disorder, and PTSD. Older residents in Rockingham County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (75.2%) and annual dental exams (74.3%), while 48.6% of men and 41.7% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include three primary care providers, one skilled nursing facility, and one public library.
