
Greenland (Rockingham)

Greenland is a town in Rockingham County with 826 residents aged 65 or older. Compared to state average rates, older residents fare better on some healthy aging indicators with lower rates of Alzheimer's disease or related dementias, anemia, chronic kidney disease, chronic obstructive pulmonary disease (COPD), congestive heart failure (CHF), diabetes, heart attack, peripheral vascular disease, pressure ulcer, stroke, tobacco use disorder, depression, and PTSD. Older residents in Rockingham County vary in obtaining preventive health screenings: residents 18 and older got annual physical exams (75.2%) and annual dental exams (74.3%), while 48.6% of men and 41.7% of women 65 and older completed all CDC recommended vaccinations and cancer screenings. Community resources to support healthy aging include one community health center and one public library.
